y Guys Dispatcher Service hereafter referred to as DISPATCHER, and Motor Carrier

ereinafter referred to as HOT SHOT/LTL CARRIER. WHEREAS, DISPATCHER is a transportation dispatcher andling the necessary paperwork between a SHIPPERS and the HOT SHOT/LTL CARRIER in order to secure 'ARGO" for said HOT SHOT/LTL CARRIER.
/HEREAS, HOT SHOT/LTL CARRIER is a Motor CONTRACT Hot Shot/LTL Carrier subject to the jurisdiction of e ICC and FMCSA: NOW, THEREFORE, in consideration of the promises and covenants hereinafted ontained it is mutually agreed by and between parties hereto as follows:
BLIGATIONS OF DISPATCHER
DISPATCHER agrees to handle paperwork, phone; fax calls to, from the BROKER to tender commodities nipments to HOT SHOT/LTL CARRIER for transportation in interstate commerce by HOT SHOT/LTL CARRIER atween points and places within the scope of CARRIER operating authority.  DISPATCHER bears no financial or legal responsibility in the transaction between the SHIPPERS and HOT HOT/LTL CARRIER agreement.
BLIGATIONS OF HOT SHOT CARRIER
HOT SHOT/LTL CARRIER agrees to pay DISPATCHER "" - ( §%) percent of the face value of loads. a flat rate of (\$) per load for dispatching services rendered, paid on a weekly basis, HOT SHOT ARRIER as stated on the load confirmation sheet. Hot Shot/LTL Carrier further agrees to pay DISPATCHER time of securing cargo if being billed on a per load basis unless prior credit arrangements have been stablished.
HOT SHOT/LTL CARRIER gives DISPATCHER authority to provide his signature for rate confirmation

neets, invoices and associated paperwork necessary for securing cargo and billing purposes. The terms of this preement shall be perpetual, provided that either party may terminate same by giving 30 days written notice to

e other.

SHIPPER agrees to pay HOT SHOT/LTL CARRIER promptly, following receipt of a freight bill and proof delivery of each shipment to its assigned destination, free of damage or shortage. The amount to be paid by HIPPER to HOT SHOT/LTL CARRIER shall be established between parties on a per shipment basis prior to ammencement of each individual shipment. A load confirmation including details of shipment and revenue to be aid

ill be supplied via FAX by SHIPPER to HOT SHOT/LTL CARRIER. Confirmation will be signed by ISPATCHER and returned via FAX to SHIPPER.

HOT SHOT/LTL CARRIER shall be liable for loss, damage, or liability occasioned by the transportation of operty arranged by DISPATCHER, SHIPPER while in the possession of carrier.

HOT SHOT/LTL CARRIER agrees to hold DISPATCHER, SHIPPER harmless from any liability for ersonal injury or property damage occurring during operation conducted by HOT SHOT/LTL CARRIER ursuant to this agreement.

HOT SHOT/LTL CARRIER will be responsible to comply with all applicable state and federal regulations extaining to the operation of a motor carrier.

OT SHOT/LTL CARRIER and DISPATCHER agree that DISPATCHER, at great expense, has developed a road customer base of shippers, receivers, and brokers that is essential to the successful operations of his ampany. HOT SHOT/LTL CARRIER and DISPATCHER agree that disclosure of the identity of one or more of e companies said customers to HOT SHOT/LTL CARRIER constitutes valuable consideration. During the term this AGREEMENT and for a period of two (2) years from its termination, HOT SHOT/LTL CARRIER shall not, rectly or indirectly, solicit or do business involving transportation or of a warehousing nature with any the ampanies customers who are serviced by HOT SHOT/LTL CARRIER as a result of this AGREEMENT unless herwise agreed by the parties in writing.

ot Shot/LTL Carrier acknowledges that the customer information being provided by DISPATCHER is the sole ack-solicit, directly or indirectly, communicate or perform any service for compensations for any account of ISPATCHER which has previously tendered to HOT SHOT/LTL CARRIER for transportation, nor shall it pass a or reveal any customer information obtained to any other person or company.

olicitation prohibited under this AGREEMENT means participation in any conduct, whether direct or indirect, e purpose of which involves transportation and/or handling of property by HOT SHOT CARRIER for which OT SHOT/LTL CARRIER does, or did in the past, provide such service for that customer under arrangements at made or procured by DISPATCHER. Solicitation includes conduct initiated or induced by HOT SHOT/LTL ARRIER, or accepted by HOT SHOT/LTL CARRIER, upon inducement by DISPATCHER efforts.

HOT SHOT/LTL CARRIER should perform services of a transportation or warehousing nature for impensation for any DISPATCHER customer without prior documented authorization from DISPATCHER uring the applicable time period in violation of this AGREEMENT, HOT SHOT/LTL CARRIER shall pay to ISPATCHER within ten (10) days of each such violation an amount equal to (8%) of all revenues invoiced by OT SHOT/LTL CARRIER to the solicited customer, Where a dispute or disagreement arises, both parties gree to tender the issue to binding arbitration in the **NEW JERSEY**.

OT SHOT/LTL CARRIER acknowledges that a breach of this provision will give rise to immediate and eparable injury to DISPATCHER, which is inadequately compensated in damages. Accordingly, HOT HOT/LTL CARRIER agrees that DISPATCHER is entitled to obtain injunctive relief against the breach or

reatened breach by HOT SHOT/LTL CARRIER of this obligation, in addition to any other legal remedies, which ay be available.

OT SHOT/LTL CARRIER further acknowledges that the precise damages DISPATCHER would sustain out of my breach of this covenant may be difficult to ascertain and agrees that it shall pay as damages, twenty five 5) percent of the aggregate of all rates and charges assessed by HOT SHOT/LTL CARRIER for transportation provided to any account of DISPATCHER that is handled in contravention of this agreement, plus juidated damages of ten thousand (\$10,000.00) dollars.

OT SHOT/LTL CARRIER agrees that it will function under terms of this agreement strictly as duly permitted intract Hot Shot carrier, and hereby waives any and all rate provisions, which may be contained in its published arrier tariffs.

nis agreement shall be deemed to be effective on the first date that HOT SHOT/LTL CARRIER, DISPATCHER, and SHIPPER commence business together, and the parties hereby agree that the provisions herein properly cores and memorialize the complete understanding as contained in any prior agreement either written or strail.
